Theoretical determination of fundamental physical constants

The article presents a theoretical method of determination of fundamental physical constants. The results of analytical calculations, including: the fine structure constant, the wave length of Compton, the electron mass, elementary charge, Planck constant, Planck mass, length and time, Planck, Newton's gravitational constant, the lifetime of the neutron.

Keywords: the fine-structure constant, the wave length of Compton, the electron mass, elementary charge, Planck constant, Planck mass length and time, Newton's gravitational constant, the lifetime of the neutron, the baryon asymmetry of the Universe

Notes:

If the parameter has a subscript $\langle \pi \rangle$ means that this theoretical parameter has a numeric value that can be used instead of the true parameter value.

Used measurement units: length $u_{\pi l} = 1,0[cM]$, mass $u_{\pi m} = 1,0[\Gamma]$, time $u_{\pi t} = 1,0[c]$ and the surface

density of mass $u_{\pi\rho S} = \frac{u_{\pi m}}{u_{\pi l}^2}$ of the Unitary of system of units.

1. The basic relationships

Let us write the expression

If n – positive integer, the expressions (1.4) and (1.5) consists of a *finite number* of members.

The algebraic equation of the form (1.3) is called valid if all its coefficients a_i – are real numbers. It is known [1, p. 39] that the corresponding equation (1.3) is a valid polynomial f(x) of the form (1.4) and (1.5) for all valid values x can take values. In the article are only valid algebraic equation of the form (1.3). We write (1.1) in the form

It is known [1, p. 38] that a general formula expressing the roots of algebraic equations through the coefficients and containing only a *finite number* of operations, additions and subtractions, multiplications, divisions and root extractions only exist for equations of degree $n \le 4$. With this in mind, we write the equation (1.1) for the case n = 3 in the form of:

Using any of the known methods for solving cubic equations (for example, the solution of Cardano [1, p. 43] or search procedure – for example, a method of half division [3, p. 472]) yields the parameter $\alpha_{\pi 0}$ – is the real root of the equation (2.1.1).

We write the equation (1.23) in the form:

The lifetime $\tau_{\pi nS}$ of short-lived neutrons $n_{\pi S}$ determine, taking into account (3.19), as

The lifetime $\tau_{\pi nL}$ of long-lived neutrons determine from (3.20), provided $\Delta y_{\pi} \cdot \alpha_{\pi} = 0$, in the form of

Note that, when presence of the neutron has two life times, the baryon asymmetry of the Universe finds its natural explanation.

$$l_{\rm P} = \sqrt{\frac{h \cdot G}{c^3}} \,. \tag{2}$$

Multiplying (1) and (2), we obtain:

$$m_{\rm p} \cdot l_{\rm p} = \frac{h}{c} \,. \tag{3}$$

Let $q_{\rm P}^{\pm} = \pm \sqrt{h \cdot c}$ – Planck charge. If $q_{\rm P}^{-} = -\sqrt{h \cdot c}$, then (1) can be written as

$$m_{\rm p} = \frac{-\sqrt{h \cdot c}}{\sqrt{G}} \tag{4}$$

and (2) in the form

$$l_{\rm P} = -\sqrt{h \cdot c} \cdot \sqrt{\frac{G}{c^4}} \,, \tag{5}$$

then, (3), given (4) and (5) can be written in the form

$$(-m_{\rm p}) \cdot (-l_{\rm p}) = + \left(\frac{h}{c}\right) \tag{6}$$

and as

$$(-m_{\rm p})\cdot(+l_{\rm p}) = -\left(\frac{h}{c}\right) \text{ or } (+m_{\rm p})\cdot(-l_{\rm p}) = -\left(\frac{h}{c}\right).$$

$$\tag{7}$$

Comment:

1. In accordance with (6) in nature should be *negative* masses and length.

2. In accordance with (7), if the constants h and c have different signs, then the charge $q_{\rm P}^- = -\sqrt{-h \cdot c}$ does not have of a valid value $q_{\rm P}^-$ – this means that in nature should not be negative charges.

The way out of this situation is to write a formula for the elementary charge e^{\pm} in the form

$$e^{\pm} = \pm \sqrt{k_{\alpha} \cdot q_{\rm P}^{\pm}} = (\pm \sqrt{k_{\alpha}}) \cdot (+\sqrt{h \cdot c}), \qquad (8)$$

where is k_{α} – a dimensionless constant.

$$e^{\pm} = (\pm \sqrt{k_{\alpha}}) \cdot \sqrt{h \cdot c} . \tag{9}$$

For the case $k_{\alpha} = \alpha$ of the elementary charge of an electron is written as:

$$e^{-} = (-\sqrt{\alpha}) \cdot \sqrt{h \cdot c} . \tag{10}$$
