## WHY THE PLANCK CHARGE IS APPROXIMATELY 11 TIMES THE ELECTRON CHARGE ABSTRACT

The Planck charge, q<sub>p</sub>, and the electron charge, e, can each be quantized based on  $m_{electron} = 1$ , on the deBroglie wavelength of the electron (= $\lambda_{electron} = h/m_{electron}C$ ) = -1 and on t<sub>electron</sub> (= $\lambda_{e;lectron}/c$ ) =  $\sqrt{-1}$ . When we do this, we see that e<sup>2</sup> equals a bit more than 1/1000 pure number.  $2\pi e^2$  thus equals about 7/1000, which equals approximately 1/137. Therefore, the inverse of  $2\pi e^2$  = approximately 137, so  $(1/2\pi e^2)^{1/2}$  = approximately 11. Now q<sub>p</sub> = [( $1/2\pi e^2$ )(hc)]e, but similar quantization of hc yields a product of  $(-\sqrt{-1})(\sqrt{-1}) = 1$ . Therefore, q<sub>p</sub> = [( $1/2\pi e^2$ )<sup>1/2</sup>(hc)]e = ( $1/2\pi e^2$ )<sup>1/2</sup>e = approximately 11 times the electron charge.

## WHY THE PLANCK CHARGE IS APPROXIMATELY 11 TIMES THE ELECTRON CHARGE

The Planck charge,  $q_p$ , is defined as the inverse of the fine-structure constant, squarerooted, times the electron charge, e. I.e.,  $q_p = 1/(e^2/h-bar c)^{1/2}e$ . Manipulating this, we obtain  $q_p = 1/(2\pi e^2/hc)^{1/2} = (hc/2\pi e^2)^{1/2}$ . If we set the electron mass to 1, the deBroglie wavelength of the electron  $(=\lambda_{electron} = h/m_{electron}c)$  to -1, and the time it takes for light to travel  $\lambda_{electron}(= t_{electron} = \lambda_{electron}/c)$  to  $\sqrt{-1}$ , we obtain imaginary values for h and c as follows:

c= 
$$\lambda_{\text{electron}}/t_{\text{electron}} = -1/\sqrt{-1} = \sqrt{-1} = t_{\text{electron}} = \sqrt{-1}$$
; and

$$\mathbf{h} = (\mathbf{m}_{\text{electron}})(\mathbf{c})(\lambda_{\text{electron}}) = (1)(\mathbf{t}_{\text{electron}})(-1) = -\mathbf{t}_{\text{electron}} = -\sqrt{-1}.$$

Then  $(hc/2\pi e^2)^{1/2} = [(-\sqrt{-1})(\sqrt{-1})/(2\pi e^2)]^{1/2}e = (1/2\pi e^2)^{1/2}e$ , and hc vanishes. Next, we quantize  $e^2$  based on the same  $m_{electron} = 1$ ,  $\lambda_{electron} = -1$ , and  $t_{electron} = \sqrt{-1}$ . In so doing,  $m_{electron} = .9109382 \times 10^{-27} \text{gm} = 1 \rightarrow \text{gm} = 1.0977693 \times 10^{27}$ ;

 $\lambda_{\text{electron}} = 2.4263102 \text{ X } 10^{-10} \text{ cm} = -1 \rightarrow \text{ cm} = -4.1214845 \text{ X } 10^9;$ 

And = t<sub>electron</sub> = .8093299 X 10<sup>-20</sup> sec = m<sub>electron</sub>  $\sqrt{-1} \rightarrow$  sec=1.23559 X 10<sup>20</sup> t<sub>electron</sub>.

Therefore,  $e^2 = (4.803 \times 10^{-10} gm^{1/2} cm^{11;2} / sec)^{2} =$ 

2.3068809 X 10<sup>-19</sup>gmcm<sup>3</sup>/sec<sup>2</sup> =

 $(2.3068809 \times 10^{-19})(1.0977693 \times 10^{27})(-4.1214845 \times 10^{9-})^3/(1.23559 \times 10^{20} t_{e;lectron})^2$ 

(Note:  $t_{e;lectron}^2 = -1$ , cancelling out.) =

1.1613108 x 10<sup>-3</sup> pure number - - a little more

than 1/1000 =

2(3.1415927)(1.1613108 X 10<sup>-3</sup>) = 7.296731 x 10<sup>-3</sup>

=1/(1000/7.296731) = 1/137.04767. Then

 $=1/2\pi e^{2} = 137.04767$ , so  $q_{p} = (1/2\pi e^{2})^{1/2}e$ 

= $(137.04767)^{1/2}$ e = 11.706736e. And that's why the Planck charge is approximately 11 times the electron charge.
